Sauna World And Salt Room Policy





An additional policy for the Brigetio Spa, which applies to all persons using the sauna world and the salt room.

- 1. Please note that by purchasing a ticket or a season ticket, you will accept the policy of the spa, sauna world, salt room and undertake to comply with it.
- 2. In the sauna world, including the sauna garden **SMOKING IS FORBIDDEN!**
- 3. The sauna service, steam cabin can only be used by healthy people and can only be used at their own risk.
- 4. Entering the sauna room is only allowed with a valid entrance ticket, and a wristband watch handed over at the time of purchasing the entrance ticket must be worn on the hand. Guests with a season ticket must ask for a wristband watch from the person at the gate before entering.
- 5. Guests are prohibited from staying in the sauna world in street clothes and shoes!
- 6. Children under 14 are not allowed to visit the sauna world! We draw the parents' attention to the fact that on Tuesdays and Sundays the Sauna World is swimsuit free.
- 7. On bathing days (Tuesday, Sunday), it is forbidden to wear swimwear in the sauna world. In the resting room, the intimate parts of the body are covered with a sheet or a towel. The splash pool can only be used nude.

- 8. Sauna seances are also available only with the use of a sauna sheet, and it is forbidden to wear swimwear.
- 9. On the swimsuit free days (Tuesday, Sunday) as well as the sauna sessions, our guests are entitled to use 1 sauna sheet free of charge. Sheets can be taken over in the sauna room. It is forbidden to take sheets from the sauna space. After use, they must be placed in collection baskets placed in the sauna world.
- 10. It is forbidden to wear bermuda pants in the sauna world of the Brigetio Spa! The ban also applies to shorter and longer versions with and without pockets.
- 11. Maximum continuous residence time in sauna and steam room for healthy people is 10-15 minutes / time, maximum 3 times a day.
- 12. Saunas and steam rooms shall not be accessible to people with incontinence, febrile or infectious patients with open wounds, nails and skin infections, or under the influence of drugs, narcotics or other intoxicants.
- 13. Towels or sauna sheets are mandatory when sitting on a sauna bench. The towel / sauna sheet should be placed so that the body surface -NOT EVEN THE FOOT - does not come into contact with the sauna bench.
- 14. Slippers or other footwear are not allowed in the saunas! The saunas have a slipper rack in the foreground. Please note that in saunas and steam rooms, the floor may be very damp so pay attention to the risk of slipping!
- 15. Beach slippers and bath slippers are mandatory in the steam cabin and in the lounges next to the saunas. All employees of Komthermál Ltd. and other persons performing official controls,

or employees of Komthermál Ltd. who visit the sauna world for any other purpose, are required to wear slippers or shoe protectors.

- 16. Before using the splashing pool, it is mandatory to use the shower for hygienic reasons. The splashing pool can only be used naked on swimsuit free days.
- 17. It is forbidden to bring a bag, fragile object or any other dangerous, injury causing object into the sauna, steam cabin and their surroundings!
- 18. It is forbidden to disturb the calmness of the Guests by improper conduct, loudness, provocative, abusive, immoral behavior! If this happens, the offender may be temporarily or permanently banned from the spa area or may be banned from using his services.
- 19. It is forbidden to eat or drink alcoholic beverages in the sauna, steam room or lounge!
- 20. Please avoid booking seats in the lounge!
- 21. It is forbidden to use different body care products (honeys, ointments, creams, etc.) in the saunas, steam baths, except for sauna sessions, where the sauna master's preparations can be used in accordance with the guidelines.
- 22. In the saunas, **watering is only allowed by the staff** and guests are not allowed to water.
- 23. It is forbidden to take photos or take other pictures in the sauna world. Komthermál Ltd. has the right to take photos or videos, but must inform the residents and ask for their consent.
- 24. It is forbidden to wear glasses and/or jewelery in the sauna for accident protection reasons!

25. Any incident, such as personal injury, fire, the presence of a dangerous device or object, should be reported to staff who are entitled and required to take action.

SALT ROOM POLICY

- 1. Use the salt room only at your own risk!.
- **2.** The salt room shall not be accessible to people with incontinence, febrile or infectious patients with open wounds, nails and skin infections, or under the influence of alcohol, drugs, narcotics or other intoxicants.
- **3.** Children under the age of 14 may only use the salt room with an adult.
- 4. Only a valid bath entry is permitted to enter the salt room.
- 5. The salt room should only be used with dry body and clothes!
- **6.** *Slippers are required in the salt room.* Non-slipper guests and escorts are required to wear a shoe protector, which can be requested at the checkout or by the lifeguards. The above rule also applies to all employees of Komthermál Ltd. and other persons performing official controls!
- **7.** Only supplies necessary for use (eg. towel onto the chair) may be brought into the salt room. It is forbidden to carry a bag or any other item capable of causing accidents or injury!
- 8. Do not eat or drink alcohol in the salt room!
